AFMA Programs Support Our Food System From Producer to Consumer

A Missed Opportunity With Summer EBT

In January, Alaska decided not to participate in the 2024 USDA Summer Electronic Benefit Transfer (EBT) program, citing administrative costs that would outweigh the benefits. This decision poses a risk to the food security of Alaskan children and misses a chance to infuse nearly \$7 million into the state's economy.

Resilient Food Systems Infrastructure Grants Request for Applications is NOW **OPEN**

The Alaska Division of Agriculture has been awarded \$2,217,448.20 from USDA AMS to award competitive grants to Alaska food and farm businesses and other eligible entities.

The purpose of the Resilient Food Systems Infrastructure (RFSI) program is to build resilience in the middle of the food supply chain, to provide more and better markets to small farms and food businesses, to support the development of valueadded products for consumers, fair prices, fair wages, and new and safe job opportunities. The Specialty Crop Block Grant Program seeks to increase production, consumption, access, knowledge and sustainability of Alaska Grown specialty crops, sustain farmers' livelihoods, and strengthen local communities. Specialty crops include fruits, vegetables, kelp, floriculture, nursery and horticulture crops. Grant projects must benefit the specialty crop industry as a whole and enhance the competitiveness of Alaska Grown specialty crops in either domestic or foreign markets. The Gus Schumacher Nutrition Incentive Program – Produce Prescription Program

The primary goal and objective of the GusNIP Produce Prescription Program is to demonstrate and evaluate the impact of projects on (1) the improvement of dietary health through increased consumption of fruits and vegetables; (2) the reduction of individual and household food insecurity; and (3) the reduction in healthcare use and associated costs. Total awards are \$500,000. Applications may only be submitted by government agencies and non-profit organizations. Award recipients may sub-award to organizations not eligible to apply provided such organizations are necessary for the conduct of the project. <u>LEARN MORE >></u>
